### OFFICIAL SCHOLARSHIP RULES

Women, Words, and Wisdom, LLC will send the award check to the financial aid office of the winner's academic institution in the name of the winner and institution (depending on the school's requirements).

Before we award the scholarship, the winner will be required to verify their academic enrollment status by providing a copy of their most recent transcript.

#### **GENERAL CONDITIONS**

Eligibility. You may apply for a chance to win a scholarship only if you meet the eligibility requirements set forth by Women, Words, and Wisdom. Additionally, scholarships are non-transferable and must be accepted as awarded and will not be paid to academic institutions outside of the United States.
